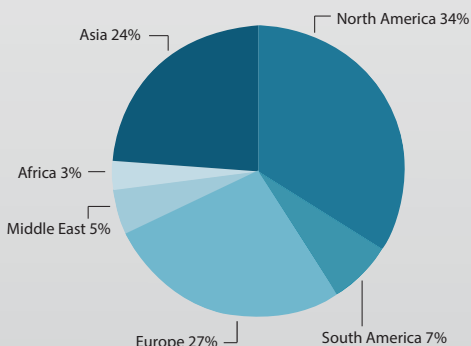

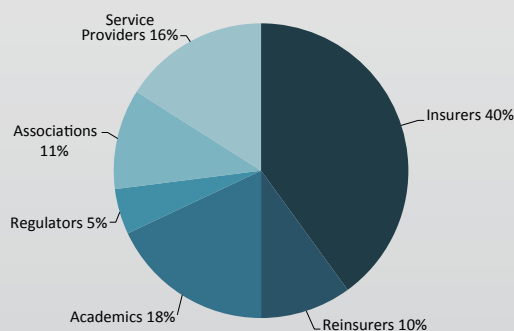

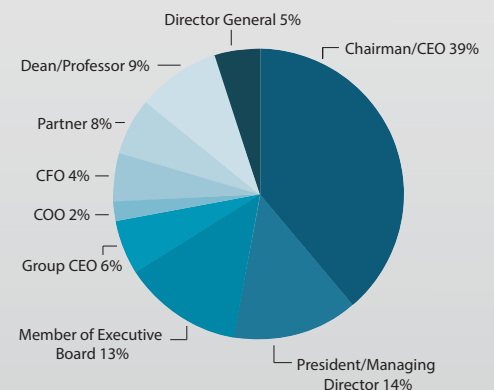
MEMBERSHIP COMPOSITION
